#### 1. Data processing.

Kalii events processes personal data for the benefit of administration and to inform stakeholders and interested parties. Kalii events does not provide personal data to third parties without your permission. Kalii events ensures the appropriate organisational and technical security of its systems in which personal data is stored. In this way Kalii events ensures that personal data is only accessible to employees who are authorised to do so by virtue of their duties, and that the personal data will only be used for the purposes for which they were obtained and for purposes that are compatible with them.

#### 2. Data collection via the internet.

Kalii events collects personal data via her website. This happens when you sign up for our Kalii events, when you sign up for an e-mail newsletter, or when you register as a user on the Kalii events website.

#### 3. Data collection outside the internet.

Kalii events also collects personal information when you register for our events. Data is also collected via registration form, telephone call or by other means.

#### 4. E-mail.

If you have provided your e-mail address to Kalii events when registering or otherwise, you will be informed by e-mail about the activities of Kalii event. #### 5. Subscribing and unsubscribing from e-mail newsletters.

#### 6. Data retention.

Kalii events will store personal data that we process on behalf of our clients and to inform stakeholders and interested parties for as long as necessary to provide services to our clients. Kalii events will keep this personal information and use it if necessary to comply with its legal obligations, to resolve disputes and to enforce agreements.

#### 7. Cookies

A cookie is a small data element that can be sent from our website to your browser and then stored on your hard drive. We sometimes use cookies on our website to enable visitors to modify certain options, but do not use cookies to monitor your browsing habits. On our servers a unique, anonymous and encrypted amount of information is stored with which individual preferences can be determined, such as language preference. However, this information does not contain any private data stored on the visitor's PC. The data in our log files are not personal and are not linked in any way to the visitors of our website. In addition to data on the date and time of your visit to the Kalii events site, the server also collects the internet address of the server that you used to connect to our website. We use this information to improve the website and to evaluate traffic statistics, such as the times in a day and the days in a week on which there are peaks, and also to check which parts of the website are visited relatively often.
